**WAC 51-54A-0105 Permits....105.7.20 Underground supply piping for automatic sprinkler system.** A construction permit is required for the installation of the portion of the underground water supply piping, public or private, supplying a water-based fire protection system. The permit shall apply to all underground piping and appurtenances downstream of the first control valve on the lateral piping or service line from the distribution main to one foot above finished floor of the facility with the fire protection system. Maintenance performed in accordance with this code is not considered to be a modification and does not require a permit.

**Exceptions:**

1. When the underground piping is installed by the aboveground piping contractor
2. Underground piping serves a fire protection system installed in accordance with NFPA 13D

All work shall comply with applicable codes and standards including NFPA 24 and the MLMC.  
The completed installation shall pass a visual inspection and hydrostatic test witnessed by a representative of the fire department. Please call the permit technician with at least 24 hours notice for inspections.  
**Contractors Materials Test Certification** shall be provided to the Fire Marshal / Fire Inspector at the beginning of the test in Accordance to WAC 212-80-088

I hereby acknowledge that the information I have provided is correct and I agree to comply with all State and City laws and any ordinances regulating construction. The issuance of a permit based on plans, specifications and other data shall not prevent the Fire Marshal from thereafter requiring the corrections of the errors in said plans, specifications and other data, or preventing building operations when in violation of this code of any State or City laws, rules or regulations. The granting of this permit or an approval does not presume to give authority to violate or cancel the provisions of any other Federal, State or City laws regulating construction, the performance of construction and/or operation of the project. Every permit issued under the provision of the MLMC shall expire by limitation and become null and void if the work authorized is not commenced for a period 180 days.
